


#### **Performance Test**

- Process 1200 tons over three days (Three-Day Test)
- Process 45 tons over three hours (Three-Hour Test)
- Divert over 50 percent of incoming MSW (Diversion Test)
- Comply with the protocol



#### **The Three–Day Test**

Can Coastal empty the floor in time?







#### **The Three–Hour Test**

Can Coastal process 174 3.5-cy bucket loads in 180 minutes?





**The Diversion Test** Can Coastal convert over 50% of MSW to products (bales, ADC, briquettes, pulp, scrap and bio-gas)?





#### <u>The Results</u>

	Standard	Result	Comments
Three-day test	1200 tons	1279 tons	Best day was 520 tons in one shift
Three- hour test	135 tons	159 tons	Equivalent to 53 tons per hour
Diversion test	50.0%	54.1%	Working on improvements



#### Next round of improvements

Reliability	Divert unprocessible items Upgrade equipment and response
Capacity	Improve materials flow Remove process bottlenecks
Diversion	Recover more pulp Improve management of plastic film and moisture
