





 - "It is the policy of the State to plan for and implement an integrated approach to solid waste management for solid waste generated in this State"





- Title 38, §2101: Solid Waste Management Hierarchy
 - <u>https://legislature.maine.gov/statutes/38/title38sec2101.html</u>
 - Waste Reduction and diversion
 - "It is the policy of the State to actively promote and encourage waste reduction measures from all sources and maximize waste diversion efforts by encouraging new and expanded uses of solid waste generated in this State as a resource." [emphasis added]



• Title 38, §1302: Declaration of policy

- "The Legislature also finds that direct state action is needed to assist municipalities in separating, collecting, recycling and disposing of solid waste, and that sound environmental policy and economics of scale dictate a preference for public solid waste management planning and implementation on a regional and state level."

• Title 38, §1304-B: Delivery of solid wastes to specific waste facilities

- <u>https://legislature.maine.gov/statutes/38/title38sec1304-B.html</u>
- "Subject to the provisions of <u>chapter 24</u>, the State requires each municipality to provide for disposal services for domestic and commercial solid waste generated within the municipality."



- Regional Approach Success
- Economies-of-scale
- Existing Infrastructure

Facility Performance History

George Aronson, Principal Commonwealth Resource Management

- First MSW accepted April 2019
- Performance testing October 22-28, 2019
- Start-stop operations through May 27, 2022

	Actual	Standard
MSW processed in 3 days	1279 tons	1200 tons
MSW processed in 3 hours	159 tons 53 tons/hr	135 tons 45 tons/hr
Diversion per mass balance	54.1%	50.0%



- Sold all recovered materials
- Produced quality pulp and briquettes
- Produced more bio-gas than anticipated
- Produced ADC approved for landfill use



Facility products: HDPE, OCC, pulp, gas, briquettes, flags
